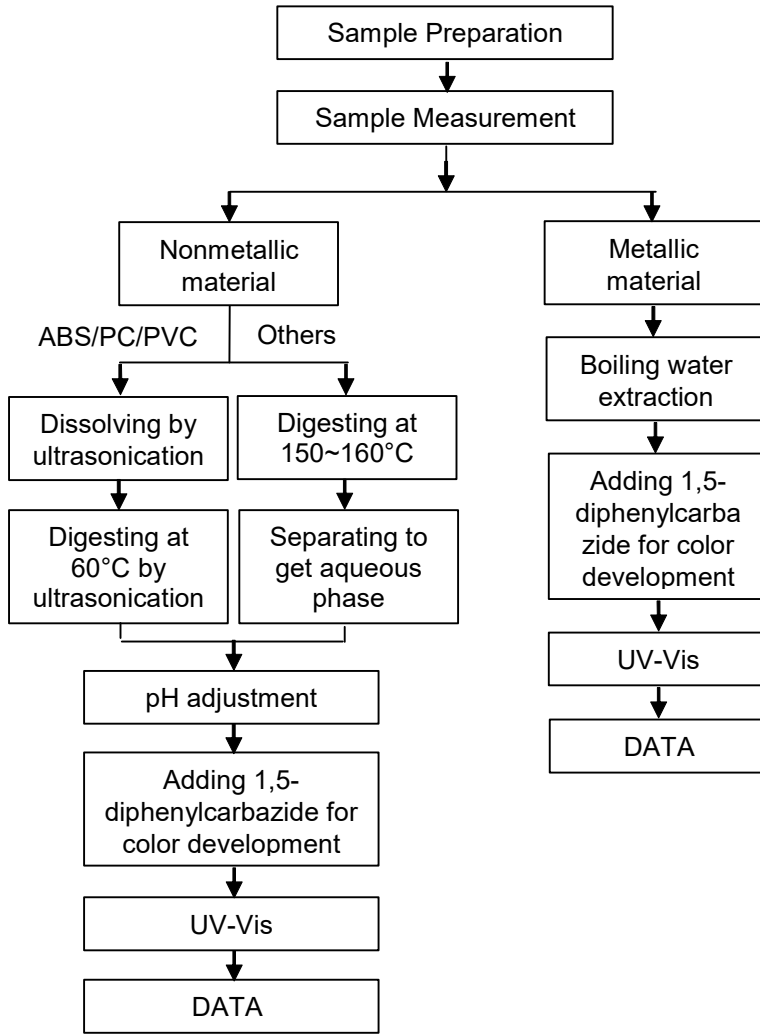

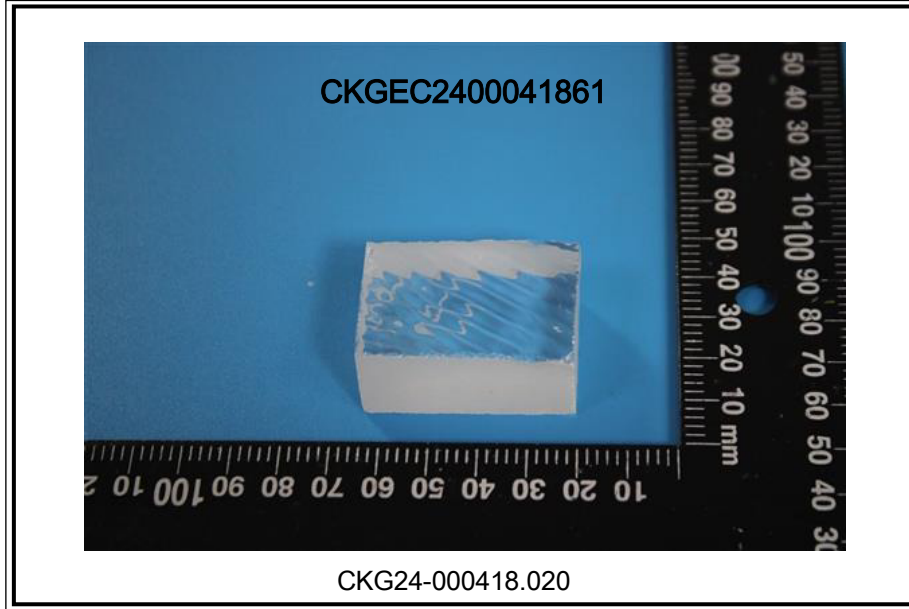
Phthalates Testing Flow Chart
