Elements Testing Flow Chart

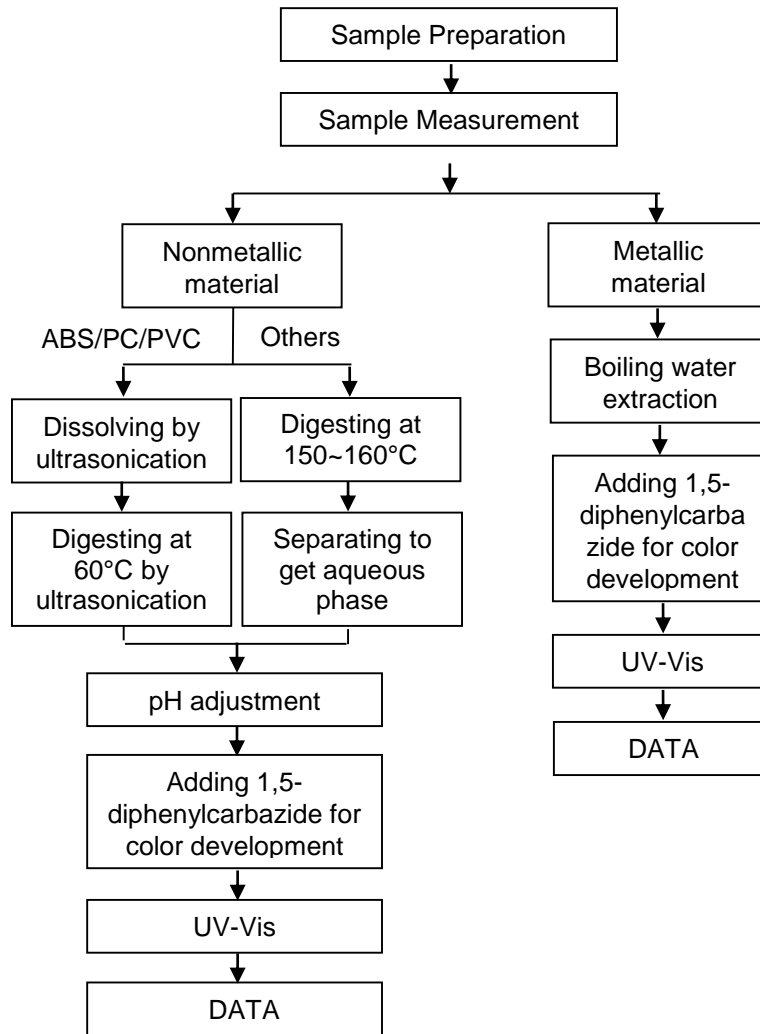

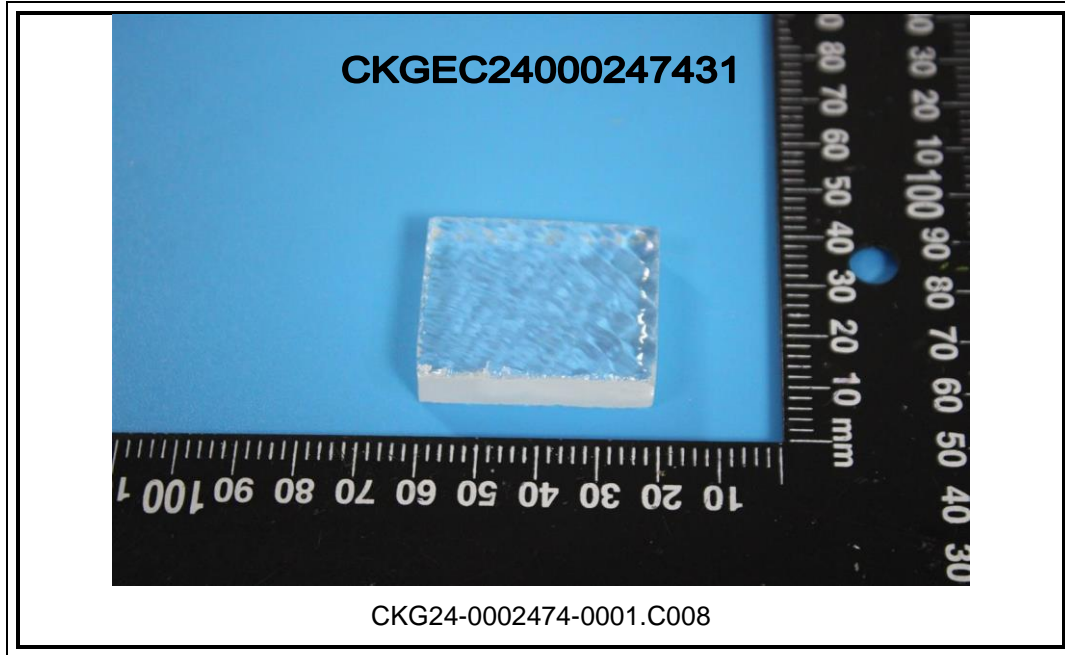
